

A Federal Court Reporter in Washington, D.C.

### From MN to DC!

A few years ago, the judge that I'd worked with for decades in state court retired. After his retirement, I decided it was time to do something different. I began researching out-of-state jobs and finally found a court to hire me, here in Washington, DC.


What a change to be working in the District of Columbia! Reporting here is incredibly interesting. We have many, many high-profile cases and cases that are fascinating to listen to. We also have quite a few daily trials, and some with realtime. In our courthouse, when there is a daily trial, we have two or three reporters working on each trial, so the work gets spread around the department.

A huge difference between federal court and state court is the formality of the proceedings. The attorneys actually come up to the podium and speak into a mic - one at a time. It's all very orderly. We normally just have one matter scheduled at a time. There are no huge calendars to get through in one sitting.

In our department we are employees of the clerk's office and assigned to a judge by the clerk. We have senior judges that do not have assigned reporters and in that case we work as a pool and our scheduling department assigns available reporters for the senior judges many of whom are quite busy. Especially now with all the January 6 cases.

There are currently 13 reporters in our courthouse, only one of which is a native Washingtonian. We have reporters from Michigan, Texas, Boston, California, Iowa, Ohio, Delaware, and, of course, Minnesota.

There is so much to do and see out here. There are all the Smithsonians, but there is so much history and beautiful country to visit. We have a couple reporters retiring soon, so if you are up for an adventure, apply!

### MAVRC Q: What is your name?

A: Lynzie Zempel

**MAVRC Q:** Where did you go to court reporting school and when did you graduate?

A: Anoka Technical College. I graduated in 2015.

**MAVRC Q:** Any particular people who have influenced you in choosing court reporting as a career or helping you during your career?

A: Jane Doby, Jen Wutz, Carol Danielson Bille, and Sandy Burch. I have been extremely fortunate that so many wonderful court reporters have mentored me during my career. Jen Wutz was my mentor when I started as an official court reporter in Duluth. Her office was next to mine. She answered every single one of my questions and calmed me down before my first trial.

**MAVRC Q:** Where have you worked since graduating, and what type of work do you do now?

A: My first job was as an official court reporter in Duluth for Judge DeSanto. When he retired, I briefly worked in Hennepin County. I then worked in Ramsey County for Judge Kyle. Currently, I am a freelance court reporter. I also do per diem as well. **MAVRC Q:** What type of steno machine and court reporting software do you use?

A: Luminex II and Eclipse.

**MAVRC Q:** Do you produce your work all on your own, or do you use scopists or proofreaders?

A: I use a proofreader. She is my hero.

**MAVRC Q:** Do you have any tips for other reporters about work habits or routines?

A: I use a "focus timer" when I work. I work for 25 minutes and

then I take a 5-minute break and do a crossword puzzle. I repeat this until I finish scoping a transcript I am working on.

MAVRC Q: Do you have a few favorite briefs to share?

A: "UTS" for "under the circumstances" will always be my favorite.

**MAVRC Q**: Are you a member of the National Court Reporters Association? If so, what credentials have you earned through NCRA and how do you earn your continuing education credits?

A: I am a member of NCRA. I am currently working on my RPR.

**MAVRC Q**: Have you attended any NCRA conventions, boot camps, seminars?



If so, how was that experience for you, and would you recommend it to other reporters?

A: I attended the NCRA convention in Las Vegas in 2021. I highly recommend attending. I learned so much and met many inspiring court reporters. I also attend the MAVRC conventions. I am looking forward to the fall convention in Rochester, MN, on September 17 and 18, 2022.

**MAVRC Q:** Do you recall when you joined MAVRC or approximately how long you've been a member?

A: I joined MAVRC in 2018.

**MAVRC Q:** When did you become a board member of MAVRC, and when does your current term end?

A: I was a secretary for two years, and a director for one year. Currently, I am the president-elect.





Following a two-year hiatus due to the COVID-19 pandemic, MAVRC members were finally able to meet in person on Saturday, April 22, for MAVRC's 2022 spring seminar. Anoka Technical College was once again the gathering place for approximately 47 attendees who were interested in expanding their knowledge base, earning continuing education points, and renewing/creating networking opportunities.

Starting off the day was Mike Padden, a civil rights attorney and author of *The Minneapolis Police Department: Blue Code of Silence: The True Story of the Murder of Terrance Franklin.* For the next hour and a half, Mike laid out his case for why he believes Terrance Franklin was innocent of the robbery charge and alleged car attack against two police officers that eventually led to five Minneapolis SWAT officers cornering him in the basement of a house. On that fateful day, Terrance subsequently lost his life after being shot 10 times, including multiple times to the head in execution style. While that alone is tragic enough, the coverup by the police following that shooting is what was most alarming to Mike and to Franklin's family.

While the book goes into great detail about the coverup and the rationale for why the officers should be charged with second-degree murder, the initial investigation by the BCA resulted in no charges being brought against the police officers. Franklin's family repeatedly rejected the police version of events and shortly thereafter hired Mike Padden and his investigative team to look into the case. Eventually a videotape surfaced that had captured a brief portion of the event, including voices of the police officers and Terrance down in the basement that occurred after the police said Terrance was dead. That videotape led to a reopening of the case. Even though no formal charges to date have been brought against any of the police officers involved in the shooting, the case has been looked at a number of times by various news outlets, and in 2021, the City of Minneapolis agreed to pay Franklin's family \$795,000 to settle the family's lawsuit out of court. While some justice has been given to the family in the death of Franklin, Mike remains resolute in his pursuit to expose the role of the Minneapolis Police Department in the tragic events of that day.

The next speaker of the day was Mark Lanterman, a highly respected and much-sought-after computer forensic scientist. In his typical entertaining fashion, Mark gave an overview of a number of cases that he helped resolve in his career, including matters involving high-profile individuals like Martha Stewart, Bernie Madoff, Tom Petters, and Paul McCartney, just to name a few.

Mark walked the attendees through the anatomy of a data breach, the elements needed for phishing and obtaining information from individuals, the internet of things, the uncovering of evidence fabrication, and the importance of iEvidence and computer native files. At the conclusion of his presentation, Mark emphasized that a person does not receive benefit from technology without paying a price. The more interactions with a computer or a cell phone you have, the more data that is being collected on you by various entities, including law enforcement agencies, and that electronic data does not lie and is difficult to erase. In other words, be mindful of the trail of evidence you are leaving that could some day come back to haunt you.

The attendees then enjoyed a delectable lunch provided by Lily's Wings, Burgers & Things. On the menu was salad, pulled pork sandwiches, French fries, and chicken wings. And if you still weren't full after all that, MAVRC members were able to choose from about 15 different ice cream flavors and treat themselves to some fried ice cream, which just happened to be one of the high points of my day!

Following lunch, the attendees heard from Ryan Antkowiak, Baird Financial, about the best ways to manage your wealth and how best to save for retirement. To assist you in figuring out how much money you need to save for your retirement, you should take your anticipated life expectancy divided by how much you spend a month, including little expenses like fast food, cable tv, gym membership, coffee, etc., to help ensure you have plenty of wealth set aside for your golden years. The earlier you start saving, the more time your money has time to grow.

## **BE THE PERSON TO MAKE A DIFFERENCE**
